## AWARD CATEGORIES:

### **VETERINARIAN OF THE YEAR**

Nominees for Veterinarian of the Year are members who have given much to the veterinary profession as well as to their community - a well-rounded member who is outstanding in the profession.

### **DISTINGUISHED VETERINARY SERVICE AWARD**

Nominees for this award are members or non-member veterinarians or non-veterinarians who have performed outstanding service to the veterinary profession and have contributed to the well-being of animals.

### **OUTSTANDING FACULTY of the COLLEGE OF VETERINARY MEDICINE**

Nominees should be faculty members of the University of Minnesota - College of Veterinary Medicine and all its related departments; who provide outstanding service to Minnesota veterinarians; who give of their time and talent to the veterinary profession; a leader who makes a difference to the profession; a dedicated contributor to organized veterinary medicine.

### **OUTSTANDING INDUSTRY REPRESENTATIVE AWARD**

Nominees should recognize an individual who has exhibited outstanding service to veterinarians and/or the MVMA. This individual should consistently provide exceptional service to Minnesota veterinarians and promote the profession through liaisons with the MVMA, veterinarians, and the profession in general. He/she does not need to be a veterinarian.

### **EMERGING LEADER AWARD**

Nominees for this award are members who have graduated within 10 years from veterinary school. He/She should have demonstrated achievement and leadership as a veterinarian with community involvement, and actively engaged with others in the profession.

## Requirements

1. Each nomination must be submitted by a MVMA member on the Veterinary Nomination form. The nomination must be made by an MVMA member; however, letters of support may come from other sources.
2. A one-page description of why the nominee should be considered must accompany the Nomination Application.

*Veterinarian of the Year - list civic and community activities.*

*Distinguished Veterinary Service - describe outstanding contribute to veterinary and for the well-being of animals.*

*Outstanding Faculty member - describe contributions.*

*Outstanding Industry Representative Award - list the service to the veterinary community.*

*Emerging Leader Award - describe achievement and leadership as young veterinarians community involvement, and actively engaged with others in the profession.*

**NOTE:** The description letters are a very important part of the nomination, be descriptive and complete.
